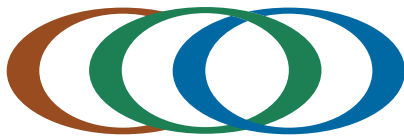

## **ANNUAL CONFERENCE TECHNICAL PRESENTATIONS AND WORKSHOP**

Did you ever wonder what a "significant nexus" is (or was)? No, it's not a shampoo or hair conditioner or a new model of an expensive vehicle. Webster defines nexus as: 1. connection, link, 2. a connected group or series. In environmental impact permitting terms, "a water body is considered to have a significant nexus with a traditional navigable water if its flow characteristics and functions in combination with the ecological and hydrologic functions performed by all wetlands adjacent to such tributary, affect the chemical, physical and biological integrity of a downstream traditional navigable water". If that explanation is as "clear as sediment in a first order stream", I invite you to attend the upcoming MAC-IECA conference and trade show in Pittsburgh, where you can listen to the experts describe what a "significant nexus" is and how you can properly employ that knowledge when applying for a permit for activities involving wetland impacts. A representative from the United States Army Corps of Engineers (USACE) and a private consultant will conduct a workshop to guide you through the process of properly completing the paperwork for the appropriate USACE Nationwide Permits.

As the host state for the 15th Environmental Conference, Workshop & Trade Show in Pittsburgh, various Pennsylvania agencies, including the PA Turnpike Commission, the PA Department of Transportation (PENN DOT) the PA Department of Environmental Protection (PA DEP), and the Pennsylvania State University will provide speakers throughout the conference. The technical programs will be presented on September 24th and the 25th. On the 24th, three tracks will be available: erosion & sediment control, stormwater management, and mining. On the 25th the United States Supreme Court decision in the "Rapanos et ux., v. United States" case will be discussed and the "significant nexus" rulings will be described. Additionally an erosion & sediment control and a slope stability and stabilization track will be available on the 25th.

John Hines, Executive Director of the PA DEP Water Planning Office and Acting Director of the PA DEP Bureau of Watershed Management will deliver an exciting keynote address during the opening session in the morning of the 24th to "kick-off" the conference.

I encourage you to take one or both days out of your busy schedule to attend the conference to learn about the efficacy and implementation of the current BMPs and to learn how to become better stewards of our natural resource base as we daily try to maintain and improve water quality in our nation's waterways.

## 2008 Golf Outing

Once again we are getting close to the annual golf tournament that precedes the MAC annual conference. This years venue is the Scenic Valley Golf Club located in Finleyville, PA. Finleyville is south of Pittsburgh approximately 12.5 miles from the Radisson Green Tree.

The Course will certainly test your bag of irons as you work your way around the track. Of course there are several Par 4's and 5's that give you the opportunity to use the big lumber off the tee. As in any well kept facility, there are several trouble spots to keep you honest.
